**Bullet points for Intergroup Reps to report at their meetings:**

- Intergroup representatives will be asked to report back to their meetings what happened at the meeting – the way this is done is up to the rep and their meeting.
- Committee continues to work on developing sponsee guidelines for DA-HOW, which will be presented to the DA-HOW Phone Meeting Intergroup (PMI) for approval before being put on the DA-HOW website
- Next month (October) we will be electing an Intergroup Service Representative (ISR)
  - This position will be someone who is representing the DA-HOW PMI at the world service level
  - We hope to fundraise to be able to send the ISR to a world service conference soon – next year or two?
  - Nominations and volunteers will be accepted at next PMI meeting (October 10 at 10:30 am Eastern)
- Elected officers – Rebekah will be leading the meetings for the next 6 months and serves as webmaster, Allison is the treasurer, secretary will rotate, we have reps from the Wed am meeting and the Wed evening meeting

**Old Business:**

- Committee working on sponsee guidelines not ready to present
  - Committee met in August, Rebekah will be sending email to committee to set up next mtg
- Candace will be the co-signer for our treasury, she and Allison will work together on this off-line

**New Business:**

- Leadership
  - Will have a leader for a 6 month term – Rebekah will take first 6 months
    - Sharon and Candace will serve as back-up if there is a conflict for Rebekah
  - Secretary – rotate on a monthly basis
  - Purpose of Intergroup (as stated by someone attending):
    - Facilitate communication between DA-HOW members
    - Provide place that newcomers can come to get information
- Intergroup Service Representative/GSR
  - Member asked – we voted in past that we would have a GSR from intergroup of DA-HOW phone meeting? Is that correct?
  - Could register the intergroup as an intergroup of DA
  - Next month we will take volunteers/nominations for Intergroup Service Representative for the DA-HOW phone meeting intergroup
  - Allison will find the form for registering as an intergroup so we could do that next month

- Secretary would create announcements for the month to send out, ask intergroup service reps to announce as meeting decides
