Old Business

Meeting Support

The Wednesday 10:30am ET meeting is struggling and asked for support. This item was carried forward from last month's meeting.

Domingo asked if anything else had been done. A member said that announcements have been made from intergroup members that the meeting needs help. And therefore, sponsor commitment is really needed.

Maria said that if everything has been tried, maybe it is time to consider letting the meeting go.

Another member supported the suggestion to let the meeting go if needed. Scott also voiced agreement with the suggestion to let the meeting go.

Domingo said that he was able to be of service to that meeting because his work schedule and would show up to the meeting and help out however he could.

Sarah made the motion to ask for support, a second was made.
